

The 2020 Annual General Meeting (**AGM**) of EFCA will be held on **Sunday, 13th September 2020**, subject to a quorum of 185, commencing at **12:30pm** as per the Notice of Meeting dated 16th August 2020.

This Info Pack provides further details regarding the AGM.

In this unprecedented time, the 2020 AGM of our church will be conducted in-person at Zenith Theatre and online through Zoom as we wish to cater for the circumstances of as many of our members as possible. Conducting the AGM this way is completely new to us, is far from simple and we anticipate technical challenges. Please pray and bear with us as we plan, organise and execute this AGM.

Procedures

To keep things simple and to minimise the duration of the AGM, we have modified our traditional approach. In particular, please note the following procedural points:

- 1. Documents circulated before the AGM is taken as read. The minutes of the 2019 AGM will not be read out aloud during the AGM (see Annexure A). The 2020 Financial Report will be taken as read and no further presentation will be made during the AGM (see pp 56-67 of the 2020 Church Annual Report (Annexure B).
- 2. Questions must be submitted in writing to the Deacons Board at least two (2) days before the meeting, i.e. by Friday, 11th September 2020. Questions must relate directly to the agenda items. Not all questions may be answered during the AGM. Any questions not answered will be addressed on a separate occasion or directly with the person.

3. No other business will be considered during the AGM. We will follow the set agenda strictly. The wordings of all motions put to the AGM are set out below and will be shown on the slides during the AGM.

We aim to complete the AGM within 60 minutes.

Quorum

A quorum of 185 is required before the AGM can commence.

If quorum is unable to be attained, we will follow the adjournment procedures in our constitution. For clarity, we intent to implement the following procedures:

- 1. If quorum of 185 is not reached by 1:00pm on 13th September 2020, the Chairman will propose, subject to the consent of members present (in-person and online) to adjourn the AGM to 1:10pm on the same date, 13th September 2020 (the Adjourned AGM).
- 2. If quorum of 185 is again not reached in the Adjourned AGM by 1:40pm on 13th September 2020, the quorum will become 3 as per the constitution.
- 3. Then, assuming we have the minimum quorum of 3, the AGM will commence.

We ask all members to <u>please register and join the AGM in-person or online</u> to ensure we have quorum on the day. If not, it will take considerable time and effort to go through the above procedure.

Registration

The Annual General Meeting will be held at the Zenith Theatre in Chatswood and live on Zoom for online attendance. Online attendance is strongly recommended as the Zenith Theatre only has a maximum capacity of 70 due to social distancing requirements.

All members must pre-register their attendance, physical and online attendance, prior to the meeting. If you do not pre-register you would not be able to attend the AGM. Each member has to register their attendance, physical or online attendance, individually.

Pre-registration will open on Mon 31 August 2020, 9am and will close on Fri 11 September 2020, 5pm.

After registration, you will receive a confirmation email containing a unique link for joining the AGM on 13 September 2020. Please do not share this unique link with anyone; each member has to register their online Zoom attendance individually for a different link to join the AGM. This is very important. First, because of security. Second, because each Zoom login will only be counted once for quorum purpose – this means, for example, if there are 3 members in your household and you login using only one link, we only count one person (i.e. the pre-registered member) for the quorum and this would make it much harder to achieve quorum for the AGM.

Procedure for Passing Motions

Adapting our traditional practice to the new in-person & online mode of AGM, we will adopt the following procedures for each motion:

- 1. Chairman asks a person to propose and another person to second the motion.
- 2. Chairman determines whether there is support by a simple majority of members present. Since we are dealing with routine matters and to simplify process, members are assumed to support the motion unless they indicate clearly otherwise as follows:
 - In-person: raise their hand and say "I object" or "I abstain".
 - Online: use Zoom chat function and type "I object" or "I abstain".
 - For both, please also mention your name clearly so we can record it properly in the minutes.
- 3. Motion is carried unless the majority object/abstain.

In-person and online attendees can all participate in this process. We will allow time for the online attendees to respond as it is recognized that there is a "time delay" between what is happening in Zenith Theatre and when that is heard by the online attendees, and vice versa. We ask all members to have patience throughout the process.

How to Propose and Second Motions?

In-person attendee can propose and second in the usual way by physically raising their hand and stating their name if ask to do so.

Online attendees can propose and second a motion by using:

Chat in Zoom. The chat message must contain the person full name (in English or Chinese) and the motion number.

E.g. "[John Chan] propose motion 1", "[John Chan] second motion 1"

To avoid confusion, <u>do not use other Zoom function</u> to show your response. Other methods will be disregarded.

General Info for Online Attendees

You will be able to see the AGM slides and also see and hear the speaker online via Zoom.

The video from the in-person AGM is under the name "EFCA - Zenith Theatre".

In Zoom, you can **Pin** that video so you can see it full screen. We will also Spotlight that video periodically to make it appears full screen.

Do not use Gallery or Thumbnail View as this will reduce the size of the video.

Please mute your audio.

Questions and Technical Issues

You can use the Chat function in Zoom to ask questions. We will have a number of Zoom host/ co-hosts to help as best as we can.

Health & Safety

We, and the management of Zenith Theatre, will use our best endeavour to clean and ensure a safe environment for everyone who attend the AGM in-person. Each person who attend in-person is, however, solely responsible for their own health and safety; they must comply with the latest health guidelines and recommendations of NSW Health and other government authorities.

We highlight, in particular, the following mandatory requirements for all in-person attendees:

- 1. DO NOT ATTEND if you are feeling unwell in any way. Please attend online instead.
- 2. Maintain social distancing at all times. This means you must stay at least 1.5m from each other (except close family member living in the same household). Only seat on designated seats in Zenith Theatre.
- 3. Wear a face mask.
- 4. Use the hand sanitizer provided.
- 5. No hugging or hand shaking.
- 6. Make sure you sign-in, providing your name and contact details.

Minutes of Annual General Meeting 2019

Date: 8 September 2019

Venue: Chatswood Church of Christ, 365 Victoria Avenue, Chatswood 2067

Chairman: Deacon Joseph Hui Secretary: Deacon Lincoln Cheung

The quorum required was 196. As members present had reached the quorum, the Chairman called the meeting to order at 1:36pm. Rev David Tse led the members with an opening prayer.

Agenda items and Minutes

1. Adoption of the Minutes of the AGM 2018

- a. The Secretary read out the minutes.
- b. Ernest Au-Yeung proposed to adopt the minutes, and Anselm Chow seconded. There were no objections. The Chairman declared that the motion was carried.

2. Adoption of the Minutes of the Special General Meeting on 4 November 2018

- c. The Secretary read out the minutes.
- d. Sylvian Chow proposed to adopt the minutes, and Eugene Au Yeung seconded. There were no objections. The Chairman declared that the motion was carried.

3. Senior Pastor's Sharing

Rev David Tse shared a message on 1 Peter 2:4-5 that the church is an organization of people and also a living organism.

4. Election of Deacons 2019/20

- a. The Chairman announced that there were 4 retiring deacons (Deacon Ash Lau, Deacon Angus Tse, Deacon Donald Tso, Deacon Alan Wu).
- b. The remaining 7 current deacons (Alvin Chan, Arthur Cheng, Lincoln Cheung, Joseph Hui, Louise Law, Claire Wong, Raymond Yu) would seek re-election.
- c. The Chairman reported that, pursuant to Rule 8.4.2 of the Constitution, the retiring Board of Deacons had determined that 11 positions are to be filled at this Annual General Meeting.
- d. The Chairman announced that, pursuant to the same rule, 7 positions were to be filled by retiring deacons and 4 positions were to be filled by nominations from the congregation.
- e. Since there were 7 retiring deacons seeking re-election, pursuant to Rule 8.4.6.1 of the Constitution, all 7 retiring deacons were deemed to be elected.
- f. Since there were 4 candidates (Denise Chan, Eppie Cheng, Darwin Hou, I-van Leong) from the congregation, pursuant to Rule 8.4.7.1 of the constitution, all 4 candidates were deemed to be elected.

5. Appointment of Delegates to the Fellowship of Evangelical Free Church of Australia 2019/20

- a. The Chairman said that all pastors are ex-officio delegates and according to Rule 2.1.3 of the constitution, there could be up to 8 FEFCA delegates.
- b. Keith Kwan, Zeus Ng would be stepping down.
- c. Kwok Tat Chan, Michael Law, Regina Lee would seek re-appointment.
- d. There were 3 new candidates (Humphrey Chan, Leon Lai, Andres Wong).
- e. There were no objections. The Chairman declared that all 6 candidates were appointed.

6. Endorsement of the Financial Report 2018/19

- a. Deacon Alan Wu, the Financial Secretary of the Board of Deacons, presented the Financial Report and reported on this year's financial position.
- b. Helena Chow proposed to adopt the Financial Report, and Frankie Lui seconded. There were no objections. The Chairman declared that the motion was carried.

7. Appointment of the Auditor for 2019/20

Susannah Kwan proposed to adopt the motion to appoint Theway Accounting Services as the auditor for 2019/20, and Stephen Yu seconded. There were no objections. The Chairman declared that the motion was carried.

8. Endorsement of the Annual Report 2018/19

Janny Ng proposed to adopt the Annual Report, and Stephen Yu seconded. There were no objections. The Chairman declared that the motion was carried.

With no further business, the Chairman invited all newly elected deacons and appointed delegates to come forward for a commissioning and closing prayer by Rev David Tse. The Chairman closed the meeting at 2:48pm.




鄭龍韜弟兄 Arthur Cheng
