

The 2024 Annual General Meeting (**AGM**) of EFCA will be held in-person at Zenith Theatre on **Sunday**, 8<sup>th</sup> **September 2024**, subject to a quorum of **156** commencing at **12:30pm** as per the Notice of Meeting dated **11<sup>th</sup> August 2024**.

This Info Pack provides further details regarding the AGM.

# Procedures

To keep things simple and to minimise the duration of the AGM, please note the following procedural points:

- 1. Documents circulated before the AGM is taken as read. The minutes of the 2022/2023 AGM will not be read out aloud during the AGM (see Annexure A). The minutes of the SGM on 5 May 2024 will not be read out aloud during the AGM (see Annexure B). The 2023/2024 Financial Report will be taken as read and no further presentation will be made during the AGM (see pp 77-96 of the 2023/2024 Church Annual Report (Annexure C)).
- 2. Questions must be submitted in writing to the Deacons Board at least two (2) days before the meeting, i.e. by Friday, 6<sup>th</sup> September 2024. Questions must relate directly to the agenda items. Not all questions may be answered during the AGM. Any questions not answered will be addressed on a separate occasion or directly with the person.

3. No other business will be considered during the AGM. We will follow the set agenda strictly. The wordings of all motions put to the AGM are set out below and will be shown on the slides during the AGM.

We aim to complete the AGM within 60 minutes.

# Quorum

A quorum of **156** is required before the AGM can commence.

If quorum is unable to be attained, we will follow the adjournment procedures in our constitution. For clarity, we intent to implement the following procedures:

- If a quorum of **156** is not reached by 1:00pm on 8<sup>th</sup> September 2024, the Chairman will propose, subject to the consent of members present to adjourn the AGM to 1:10pm on the same date, 8<sup>th</sup> September 2024 (the Adjourned AGM).
- 2. If a quorum of **156** is again not reached in the Adjourned AGM by 1:40pm on 8<sup>th</sup> September 2024, the quorum will become 3 as per the constitution.
- 3. Then, assuming we have the minimum quorum of 3, the AGM will commence.

We ask all members to <u>please register and join the AGM</u> to ensure we have quorum on the day. If not, it will take considerable time and effort to go through the above procedure.

# Registration

The Annual General Meeting will be held in person at the Zenith Theatre in Chatswood.

All members must pre-register for their attendance, prior to the meeting. If you do not pre-register, you would not be able to attend the AGM. Each member must register their attendance individually.

Pre-registration will open on Sunday 25<sup>th</sup> August 2024, 9am and will close on Fri 6<sup>th</sup> September 2024, 5pm.

- 2. Chairman determines whether there is support by a simple majority of members present. Since we are dealing with routine matters and to simplify process, **members are assumed to support the motion unless they indicate clearly otherwise** as follows:
  - Raise their hand and say "I object" or "I abstain".
  - Please also mention your name clearly so we can record it properly in the minutes.
- 3. Motion is carried unless a majority object/abstain.

Attendees can all participate in this process. We ask all members to have patience throughout the process.

# How to Propose and Second Motions?

All attendees can propose and second in the usual way by physically raising their hand and stating their name if ask to do so.

# Minutes of 2022/2023 Annual General Meeting

The quorum required was **171**. As members present (**192** at 12:30pm and **222** in total) had reached the quorum, the Chairperson called the meeting to order at **12:30pm**. Rev David Tse led the members with an opening prayer.

#### Agenda items and Minutes

1. Senior Pastor's Sharing - Rev David Tse shared a message

#### Acts 15.1-13 - Together We Discern God's Leading

- o 3 Important Principles
  - Christians may disagree even when we all seek to do God's will
  - Preparation for Discernment is more important than the actual process of discernment – especially in preparing the person
  - To prepare ourselves adequately is the responsibility of each one of us before God.

#### 2. Adoption of the Minutes of the 2021/2022 Annual General Meeting

**Philip Cheung (English)** proposed to adopt the Minutes of 2021/2022 Annual General Meeting. **Stephen Yu (English)** seconded. There were no objections. The Chairperson declared that the motion was carried.

# 3. Endorsement of the 2022/2023 Financial Report

**Helena Yue (Mandarin)** proposed to adopt the 2022/2023 Financial Report. **Ernie Au Yeung (English)** seconded. There were no objections. The Chairperson declared that the motion was carried.

# 4. Appointment of the Financial Auditor for 2023/2024

Janny Ng (Cantonese) proposed to adopt the motion to appoint Theway Accounting Services as the financial auditor for 2023/2024. Louise Law (Cantonese) seconded. There were no objections. The Chairperson declared that the motion was carried.

# 5. Endorsement of the 2022/2023 Annual Report

- a. The Chairperson thanked **Ash Lau (Cantonese)** for his hard effort on designing and producing the annual report and all brothers and sisters who contributed to the report.
- b. **Stephen Yu (English)** proposed to adopt the 2022/2023 Annual Report. **Edward Wong (Cantonese)** seconded. There were no objections. The Chairperson declared that the motion was carried.

#### 6. Election of Deacons 2023/24

- a. The Chairperson announced that there are 4 retiring deacons (Joseph Hui, Vivien Zheng, Darwin Hou and Andres Wong).
- b. The Chairperson reported that, pursuant to Rule 8.4.2 of the Constitution, the retiring Board of Deacons had determined that 11 positions are to be filled at this Annual General Meeting. And pursuant to the same rule, 7 positions were to be filled by current deacons offering for re-election and 4 positions were to be filled by nominations from the congregation.
- c. The remaining 7 current deacons (Dennis Law, Eppie Cheng, I-van Leong, Felix Tang, Leo Pang, Stanley Xie and Zeus Ng) would seek re-election.
- d. Since there were only 4 new deacon nominations (Ernie Au Yeung, Ricky Poon, Lincoln Cheung and Tracy Liu) from the congregations, pursuant to Rule 8.4.6.1 & Rule 8.4.7.1 of the constitution, all 7 current deacons offering for re-election and 4 new deacons offering for election were deemed to be elected.
- e. **Anselm Chow (Mandarin)** proposed to adopt the Election of Deacons 2023/24. **Ryan Poon (English)** seconded. There were no objections. The Chairperson declared that the motion was carried.
- 7. Appointment of Delegates to the Fellowship of Evangelical Free Church of Australia 2023/2024
  - a. Regina Lee and Ruby Li would seek re-appointment.
  - b. There are 4 new FEFCA Delegate candidates (Eva Chan, Veronica Poon, Vivien Zheng and Wendy Yu) for 2023/2024 from the congregations.
  - c. Arthur Cheng (English) proposed to appoint all 6 Delegates to FEFCA for 2023/2024.
    Pearl Cheung (English) seconded. There were no objections. The Chairperson declared that the motion was carried.

With no further business, the Chairperson invited all newly elected deacons and appointed delegates for a commissioning and closing prayer by Rev David Tse and Rev Joshua Mak. The Chairperson closed the meeting at **1:23pm**.

#### Agenda

• To vote on the following motion:

That the Board of Deacons (the Board) be authorised to:

- Purchase the site at 518 Pacific Highway, Lane Cove North (the 518 Site) as the new church property as the Board sees fit;
- Sell the existing church property at 28-30 Wellington Road, East Lindfield (the East Lindfield Property) after the exchange of contracts for the purchase of the 518 Site; and
- Use the East Lindfield Property and/or the 518 Site as security to obtain secured loans in connection with the purchase and/or renovation of the 518 Site, if the Board sees necessary.

#### Minutes

- 1. The Chairman called the meeting to order at 1:20pm as members present had reached the quorum of 171.
- 2. The meeting was conducted in three languages with Deacon Tracy Liu providing Mandarin interpretation and Deacon Leo Pang providing English interpretation.
- 3. Rev Joshua Mak led the opening prayer.
- 4. Rev David Tse made a sharing to encourage each member to, individually through prayers, be humbly moved by the Holy Spirit and, collectively through the voting, truthfully witness God's guidance for EFCA on the purchase of the 518 Site.
- 5. The Chairman announced that the scrutineers will be counting under the supervision of Alan Wu. The Chairman requested the members present to nominate 10 scrutineers. The following were nominated and seconded without objection:

- 6. The Chairman explained that the motion is proposed according to Clauses 12.1 and 12.2 of the EFCA Constitution. The Chairman provided the latest update on the project.
- 7. The Chairman explained the voting procedure. The members present filled in the ballot papers. The scrutineers collected the ballot papers with 5 collection boxes and counted the ballot papers.
- The Chairman announced that the number of ballot papers issued was 416 and the number of YES votes required to pass the motion was 312. The result was 323 YES votes, 83 NO votes, and 9 blank votes. The number of ballot papers collected was 415.
- 9. The Chairman announced that the motion was passed.
- 10. Rev David Tse led the closing prayer. The meeting was closed at 2:40pm.
